WHEREAS, Proposition 9 and the Moscone Bill (Sections 87202 and 3701 (b) of the Government Code respectively) require filing of financial statements by an appointee to a Council seat ten days prior to his assuming office; and


WHEREAS, said statements were filed as required on January 13, 1975; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that pursuant to Section 12 of the City Charter, the Council in said executive session appointed Jesse D. Haro of 2757 Dove Street in the City of San Diego to the Councilmanic seat of the 8th District to complete the term expiring on December 8, 1975.

BE IT FURTHER RESOLVED, that said appointment shall become effective on January 23, 1975.
