WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and


WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

| Clarence D. Barkley | BUILDING INSPECTION | \$95 | The suggester, while an Electrician working at the San Diego Stadium, became concerned with the number of pump motors for drainage that burned out. He proposed screens over the intake pipes for the pumps so that damaging debris would be kept out of the pumps. These have been in use about two years, and have been found to prevent 7 motor burn-outs per year. The saving is \$890 per year. |
| Wilbert O. Weaver | POLICE DEPARTMENT | \$50 | This Officer suggested a procedure to be used while taking fingerprints so that Identification Technicians would not be required to appear in court in regard to the prints. This will save at least \$500 per year, and it is expected it will be found to be more. |
| Carmelinda A. Wood | GENERAL SERVICES Equipment Division | \$40 | The suggester, an Intermediate Typist, proposed a new form to save time in reporting changes in labor cards for payroll purposes. The form was not adopted, but the suggestion led directly an improved system that may save about \$800 in a year. An initial award of \$40 is recommended. |
