APPROVING MAP OF FIRST ASSEMBLY OF GOD
CHURCH

JAN 23 1975

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, entitled "FIRST ASSEMBLY OF GOD CHURCH Being a subdivision of portions of Lots 5 and 6 of Pueblo Lot 1186 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof made in the action entitled 'Harold M. Schiller vs. O. J. Stough, et al.' in Superior Court Case No. 1532 on file in the office of the County Clerk of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Salisbury Drive and the right-of-way for pedestrian and non-motor vehicular use, for public purposes, and said street and right-of-way are hereby declared to be a public street and public right-of-way and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as granted and shown on

said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and right-of-way are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
