WHEREAS, the City Council on September 12, 1974, accepted the report entitled "Temporary Paradise? A Look at the Special Landscape of the San Diego Region" prepared by Donald Appleyard and Kevin Lynch; and

WHEREAS, the City Council directed the City Manager, the Planning Director, and the City Attorney to review the recommendations made in the report with an eye toward possible implementation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That appropriate City Staff are instructed to incorporate appropriate policies and recommendations as part of an Urban Design Component of the General Plan.

2. That City Staff is instructed to return in one year with a report that will:

- a. Identify a detailed work program of study.
- b. Identify the time and possible costs and staff of such a program.
- c. Identify the participants of a multi-disciplinary team.
- d. Identify how the products will be used.
- e. Identify funding costs.
