BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$28,000 within the Sewer Revenue Fund 506 from Unallocated Reserve (68.91) to Waste Water Research (62.17) for the relocation of the Reverse Osmosis Water Reclamation Pilot Plant.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the relocation of said Reverse Osmosis Water Reclamation Pilot Plant, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
