BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of City, an agreement with KAUFMAN AND BROAD, INC., a corporation, for the construction by said corporation of improvements on Mira Mesa Boulevard, adjacent to property owned by the San Diego Unified School District, in connection with the development of Mirador Unit No. 1 subdivision, a distance of approximately 1,340 feet, and to provide for payment by the City in an amount not to exceed \$21,994.86 which said payment shall be made to said corporation upon receipt of funds from the San Diego Unified School District.
