AZUS, husband and wife, executed in favor of The City of San Diego, bearing date of January 10, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots F and G, Block 76, Horton's Addition, according to Map thereof by L. L. Lockling filed in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named G STREET.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
