
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of \$7,700 is hereby authorized out of Park and Recreation Bond Fund 725, solely and exclusively, for design construction and related expenses in connection with the above agreement.
