CATHERINE SUBDIVISION Being a subdivision of Lot 11, Balboa Towers Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5638, filed in the office of County Recorder of San Diego County, October 20, 1965.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
