APPROVING MAP OF ZEVELY SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by G. Harlan Dye, Licensed Land Surveyor, entitled "Zevely Subdivision Being a subdivision of portions of Lots 37 and 40 of Map of Lot No. 12 Ex-Mission Ranch according to Map thereof No. 859 in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Lincoln Place, for public purposes and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Harlan Place and portion of Lot 117, marked "Reserved for Future Street," per Halecrest Heights Unit No. 1, Map No. 4747, adjacent and contiguous to Lot 1, all as shown on this map within this subdivision.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of

a public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
