William F. Hotchkiss	POLICE DEPARTMENT	\$1000	Over 13,000 follow-up crime investigation reports are required each year. This Lieutenant devised a new procedure that develops the required information, but which eliminates the necessity of making the special report. This saves over \$20,000 per year, and saves the time of more than one Police Officer for more productive activities than paper work.
Patricia L. Whitelock	ENGINEERING & DEVELOPMENT	\$150	This Intermediate Typist felt that not every soil test report made and sent out was really wanted by the recipient. A trial was made for about three months during which only reports requested were sent out. This resulted in only about one-fourth the usual number of reports. The saving is estimated to be a little more than \$1500 per year.
