BE IT FURTHER RESOLVED, that the expenditure of \$3,500 from Gas Tax Fund 220 of The City of San Diego be and it is hereby authorized solely and exclusively for the purpose of providing funds for the above-described services and related expenses, supplementing Resolution No. 210323.
