

That the offer of Haaker Equipment Company is hereby accepted, and the City Manager is hereby authorized to execute a contract for a 12-MONTH LEASE OF A VACUUM DRAIN CLEANER beginning February 20, 1975, for a cost of \$2,789.86 per month, with options to purchase at the end of the 12-month period for \$31,725.91 plus sales tax or continue lease at the same price and terms for an additional 12-month period with a \$1.00 purchase price at the end of the total 24-month period, plus sales tax.
