


RESOLUTION No. 212588Adopted on FEB 6 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA to include the roadway construction at the intersection of 47th Street and Imperial Avenue in the State's Interstate Route 805 construction, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 750182.

BE IT FURTHER RESOLVED, that the expenditure of \$75,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design and construction of the aforementioned project and related expenses.
