Modified Drawing Nos. 15435-1-D through 35-D and New Drawing Nos. 15435-5AD and 6AD modifying certain work filed in the office of the City Clerk as Document No. 750444 and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
