RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, AWARDED
CONTRACT.

(Standley Park Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 the Council adopted Resolution No. 212226 ordering the giving of notice inviting sealed bids for the construction of the improvements described in the Report of the Superintendent of Streets and approved by Resolution No. 212225 and the notice has been duly published; and

WHEREAS, at the time and place fixed, all sealed bids for the construction which were filed with the Purchasing Agent were publicly opened, examined and declared and a report of the results of said bidding submitted to the Council; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The bid of LOUETTO CONSTRUCTION, INC.

is the lowest bid by any responsible bidder for the construction of the improvements and is accompanied by a good and sufficient bid check or bond which is satisfactory to the Council. Said bid is hereby accepted and the contract for the construction awarded to the above-named bidder at the prices named in said bid.

Section 2. All bids, other than the bid above accepted, are hereby rejected and the Purchasing Agent is directed to return to each bidder whose bid is so rejected the check or bond which accompanied his bid.
