
**RESOLUTION No. 212641**

SHATTUCK and DEBORAH SHATTUCK for the construction of improvements on Picador Boulevard, a distance of approximately 2000 feet, within the limits of ROYAL PARK UNIT NO. 3 subdivision, and to provide for reimbursement by the City out of Gas Tax Fund 220 in an amount not to exceed \$4,574.34, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 750296.
