
RESOLUTION No. 212662

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Council Resolution No. 212398, adopted on January 9, 1975, be and it is hereby amended by adding the PREVAILING WAGE RATES for Traffic Surface Protective Coating Applicator, Journeyman Striper, Traffic Delineation Device Applicator, Serviceman, Trainees and Helper, and correcting the PREVAILING WAGE RATES of the Sheet Metal Workers, pursuant to Exhibit A attached hereto and made a part hereof.
2. That the City Clerk be and he is hereby directed to cause to be published such amendment to the PREVAILING WAGE RATES schedule, one time in the San Diego Daily Transcript, a newspaper published daily in said City and of general circulation.
