<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Mary Rose Fisher	CITY ATTORNEY	\$60	This Intermediate Typist is in the Fraud Unit of the Criminal Division. The filing system she found was extremely cumbersome and delay causing for Attorneys and others. She worked out a new filing system, including a cross-reference, which saves a considerable amount of time and improves service.
John R. Lewis	POLICE DEPARTMENT	\$40	Sgt. Lewis felt that the established practice of making out Contact Reports for juveniles apprehended for truancy was unnecessary as the cases are handled by the schools. About 600 reports per year have been eliminated for a \$419 saving.
Mary Lou Brown	WATER UTILITIES	\$30	The suggester, an Intermediate Typist, became concerned with the difficulties involved in the payment of gas and electric bills by many City accounts. Her suggestion contributed to the improved system saving an estimated \$297/yr.
Earl B. Kinsel	BUILDING INSPECTION	\$20	Mr. Kinsel is an Intermedite Typist. Building. Relocation Permits are required to move buildings. He observed that when portable schools are moved there is no need for a permit. Discontinuing these saves about \$180/yr. in time and forms.
