That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for **COMPLETE MAINTENANCE SERVICES TO INCLUDE THE IRRIGATION, FERTILIZATION, BASIN REPAIR AND LITTER CONTROL FOR APPROXIMATELY TWO THOUSAND AND FIFTY TREES (2050) ON SELECT MAJOR STREET RIGHTS-OF-WAY CITY-WIDE FOR TWELVE (12) MONTH PERIOD COMMENCING APRIL 18, 1975 AND ENDING APRIL 17, 1976, San Diego, California**

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
