

**RESOLUTION No. 212698**

Adopted on FEB 27 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the County of San Diego for the purpose of the County's providing personnel and administrative services relating to the conduct of the 1975 Special Population Census, pursuant to the terms and conditions set forth in the form of agreement between the County of San Diego and The City of San Diego for the taking of a 1975 census, on file in the office of the City Clerk as Document No. 750354.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized and directed to set aside the sum of \$300,000 remaining in Department 43.11, Population Estimate, to be expended solely and exclusively for defraying costs incurred by the above agreement.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby further authorized and directed to transfer within the General Fund 100 the sum of \$60,000 from Unallocated Reserve (53.31) to Professional Services, Department 43.11, Population Estimate, to be further set aside and used solely and exclusively for defraying costs incurred by the above mentioned agreement.
