BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, entitled "NAVAJO PLAZA NO. 1 Being a subdivision of a portion of Lot 70 of Rancho Mission of San Diego, according to Map thereof made in the Action No. 15191 entitled 'San Diego Realty Company vs. Maria Y. Olvera De Toro, et al.', filed in the Office of the County Clerk of San Diego County, in the City of San Diego, County of San Diego, State of California, together with a portion of Navajo Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following portion of street: portion of Jackson Drive for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,

that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
