BE IT FURTHER RESOLVED, that for any proposed rate or charge increase above the maximums stated in Documents

Nos. 750642 and 750643 the operator must make application for a rate hearing in accordance with the City's adopted "Rules and Procedures Governing Cable Television Rate Applications."
