Authorizing the submittal of an SCA 15 Application to the state for the purpose of funding the development of a detailed financial implementation program, preliminary design, performance specifications and evaluating bids for implementation of the MAC Transit System in Center City.

WHEREAS, The Council of the City of San Diego has authorized a feasibility study of a MAC Transit System to meet the mobility requirements within Center City to 1995; and

WHEREAS, That feasibility study has been completed and a determination has been made that a MAC Transit System for Center City should be implemented; and

WHEREAS, The recommended source of funding for system implementation is the monies appropriated under State Constitutional Amendment (SCA 15); and


WHEREAS, The Center City plan recommends implementation of a MAC Transit System; and

WHEREAS, Guidelines for processing SCA 15 Grant Applications require the submittal of an application to the local CALTRANS district office on or before March 15, 1975;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager (or his authorized representative) be and is hereby directed to seek SCA 15 funding for the purpose of: developing detailed financial plans, preparing system performance specifications, seeking and evaluating bids and preparing preliminary designs for system implementation.

BE IT FURTHER RESOLVED that the City Manager (or his authorized representative) is directed to prepare and submit the necessary grant applications.
