
Adopted on MAR 6 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of dedication of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, executed in favor of The City of San Diego, bearing date of February 11, 1975 conveying to said City an easement for a public street or highway purposes, to wit, a bicycle path, over and upon a portion of Pueblo Lot 1272 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of said County of San Diego, November 14, 1921, as Miscellaneous Map No. 36, and a portion of Lot 1, Spreckels Subdivision, according to Map thereof No. 5535, as more particularly described in said deed be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a bicycle path and the same is hereby named Governor Drive.

That the City Clerk of said City is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution, for record in the office of the County Recorder of San Diego County.
