A RESOLUTION AMENDING RESOLUTION NO. 194944 WHICH DECLARED THE NEED FOR A HOUSING AUTHORITY IN THE CITY OF SAN DIEGO, CALIFORNIA, AND DECLARED THE CITY COUNCIL OF THE CITY TO BE COMMISSIONERS OF THE HOUSING AUTHORITY, DESIGNATED A CHAIRMAN FOR THE AUTHORITY, AND APPROVED THE APPLICATION OF THE PROVISIONS OF SECTION 23 OF THE UNITED STATES HOUSING ACT OF 1937, AS AMENDED, TO THE CITY OF SAN DIEGO.

WHEREAS, the Council of The City of San Diego, by Resolution
No. 194944, adopted October 3, 1968, declared the need for a Housing
Authority in The City of San Diego, declared itself to be Commissioners
of said Housing Authority, designated a Chairman for the Authority
and approved application of the provisions of Section 23 of the
United States Housing Act of 1937, as amended, to The City of San
Diego; and

WHEREAS, the Council of The City of San Diego hereby determines, finds and declares that there are additional programs that have been enacted by federal and state legislation for providing leased housing for low-income families, the elderly and the handicapped; and

WHEREAS, the Council of The City of San Diego hereby determines, finds, and declares that:

- (a) There continues to be a shortage of safe and sanitary dwelling accommodations in The City of San Diego available to persons of low income at rentals they can afford;
- (b) There continues to be a need for a Housing
  Authority to function in The City of San Diego.

  NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the title of Resolution No. 194944 is hereby amended to read as follows:

A RESOLUTION DECLARING THE NEED FOR A HOUSING AUTHORITY IN THE CITY OF SAN DIEGO, CALIFORNIA AND DECLARING THE CITY COUNCIL OF THE CITY TO BE COMMISSIONERS OF THE HOUSING AUTHORITY, DESIGNATING A CHAIRMAN FOR THE AUTHORITY, AND APPROVING THE APPLICATION OF THE PROVISIONS OF SECTION 23 OF THE UNITED STATES HOUSING ACT OF 1937, AS AMENDED, AND THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, TO THE CITY OF SAN DIEGO.

BE IT FURTHER RESOLVED, that Section 3 of Resolution No. 194944 is hereby deleted in its entirety.

BE IT FURTHER RESOLVED, that Section 4 of Resolution No. 194944 is hereby amended to read as follows:

Section 4. The City Council declares that the application of the projects of Section 23 of the Housing Act of 1937, as amended, and The Housing and Community Development Act of 1974, to The City of San Diego is hereby approved.
