
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$177,300.00 from Model Cities Fund 2903, Third Action Year, is hereby authorized solely and exclusively for the exercise of said option with Greenwood Memorial Park, Inc..

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that deed of GREENWOOD MEMORIAL PARK, INC. and GREENWOOD MEMORIAL PARK, a California corporation, to be executed in favor of The City of San Diego, conveying to said City the above described property, the form of which deed is on file in the office of the City Clerk as Document No. 750505, is hereby authorized and approved.
