RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AWARDING A CONTRACT TO IMPROVE
CAMINO RUIZ, BLACK MOUNTAIN ROAD AND
MIRA MESA BOULEVARD.

WHEREAS, the Purchasing Agent of The City of San Diego, California, as authorized by City Council Resolution No. 211998 did on January 15, 1975, publicly open, examine and declare all sealed proposals or bids for doing work and improvement described in Resolution of Intention No. 211997 as modified and amended by Resolution No. 212617, which Resolution of Intention and modification and amendment are hereby expressly referred to for description of said work and improvement, and for all particulars relative to the proceedings under said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council of The City of San Diego, California, hereby rejects all said proposals or bids except that herein mentioned and hereby awards the contract for doing said work and improvement to the lowest regular responsible bidder to wit: GRIFFITH COMPANY, a corporation, for ALTERNATE 4, at the prices named in the bid of said bidder on file in the office of the City Clerk.

2. That the City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.

3. That the expenditure of \$114,272 is hereby authorized out of Gas Tax Fund 220, solely and exclusively, for the above stated purpose.

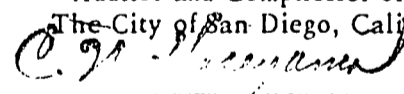
CERTIFICATION OF UNENCUMBERED BALANCE
