That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, for the installation of traffic signals and safety lighting on Camino Del Rio South and Mission Center Road, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 750489.

BE IT FURTHER RESOLVED, that the expenditure of \$4,000 is hereby authorized out of Gas Tax Fund 220, solely and exclusively for the purpose of providing funds for deposit with the State for installation of said conduit.
