WHEREAS, The City of San Diego has undertaken a certain project designated Southeast Involvement Project funded in part from funds made available through the Omnibus Crime Control and Safe Streets Act of 1968, PL 90-355, as amended, PL 91-644 (hereafter referred to as the Safe Streets Act), administered by the California Council on Criminal Justice (hereafter referred to as CCCJ); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager of The City of San Diego is hereby authorized, for and on behalf of said City, to make an application for law enforcement purposes to CCCJ pursuant to the terms and conditions set forth in the form of Third Year Grant Application on file in the office of the City Clerk as Document No. 750517, and is further authorized to execute, for and on behalf of said City, a Grant Award Contract for law enforcement purposes.

BE IT FURTHER RESOLVED, that the applicant agrees to provide matching funds as may be required for said project under the Safe Streets Act and the rules and regulations of CCCJ and the Law Enforcement Assistance Administration.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant on-going law enforcement expenditures.
