
**RESOLUTION No. 212819**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Fifth Amendment to that certain Operating Agreement - Wild Game Preserve, a copy of which agreement is on file in the office of the City Clerk as Document No. 727223, as amended, with the ZOOLOGICAL SOCIETY OF SAN DIEGO, INC., a nonprofit California corporation, to provide for lease payment from the Zoological Society to the Water Utilities Department for fair rental value of the property, to be evaluated every five years, under the terms and conditions set forth in the form of Fifth Amendment to Agreement on file in the office of the City Clerk as Document No. 750530.
