BE IT RESOLVED, by the Council of The City of San Diego as follows:



That the bids of: Carlon Meter Sales Co.; Rockwell International; Gamon-Calmet Industries, Inc.; Hersey Products, Inc.; Muesco Inc.; Badger Meter Inc., and Neptune Water Meter Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for COLD WATER METERS AND PARTS for a period of one year beginning March 1, 1975 through February 29, 1976 per prices on file in the Purchasing Department as follows:

1. Carlon Meter Sales Co. for all of Schedule I for domestic water meters and the bid of Carlon Meter Sales Co. for parts for Carlon meters at a 20% discount from list price, plus sales tax, terms net 30 days, with an option to renew for an additional year.
2. Rockwell International for items 3, 5 and 6 of Schedule II for turbine meters and the bid of Rockwell International for parts for Rockwell meters at a 40% discount from list price, plus sales tax, terms net 30 days.
3. Gamon-Calmet Industries, Inc. for Item I of Schedule II A for compound meters and the bid of Gammon-Calmet Industries, Inc. for parts for Gamon-Calmet meters at a 50% discount from list price, plus sales tax, terms net 30 days, F.O.B. Florence, KY.
4. Hersey Products, Inc. for items 1 and 4 of Schedule II for turbine meters and the bid for all of Schedule IV for general service meters and parts for Hersey Meters at list price, plus sales tax, terms net 30 days.
5. Muesco Inc. for parts for various meters at list price, plus sales tax, terms net 30 days.
6. Badger Meter Inc. for parts for Badger meters at list prices, plus sales tax, terms net 30 days, with an option to renew for an additional year.
7. Neptune Water Meter Co. for parts for Neptune meters at a 10% discount from list price, plus sales tax, terms net 30 days, F.O.B. Los Angeles, CA.
