

RESOLUTION NO. 212870

WHEREAS, ELIZABETH EAGON has applied to the City Council for a Certificate of Public Convenience and Necessity to operate an automobile for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(1) The applicant desires to perform an on-call personal automobile for hire service within the City of San Diego. The name of the proposed business will be Bettye Eagon's Driving and Shopping Service;

(2) The vehicle proposed for use is a pale yellow 1973 Datsun 1200 four-door sedan. Seating capacity of the vehicle is four persons. This vehicle has been satisfactorily inspected by the Police Department;

(3) There appears to be a need for this type of service and the proposed automobile for hire service will not conflict with existing taxicab, automobile for hire, or bus services;

(4) It has been determined that the service will not add to traffic congestion;

(5) All of applicant's personal and business references have been checked and found to be satisfactory; and


WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That Elizabeth Eagon, dba Bettye Eagon's Driving and Shopping Service, having filed an application for a Certificate of Public Convenience and Necessity to operate one automobile for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, a Certificate of Public Convenience and Necessity is hereby granted to Elizabeth Eagon, dba Bettye Eagon's Driving and Shopping Service, to operate the vehicle specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
