

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the use proposed by Mr. Loch Crane as hereinabove identified is within the meaning of the provision of the Declaration of Restrictions which allows "administrative and professional offices related or accessory to permitted uses."
