WHEREAS, Section 21101 of the Vehicle Code of the State of California provides that local authorities may adopt rules and regulations by resolution on the matter of temporarily closing a portion of any street for celebrations, parades, local special events and other purposes when such closing is necessary for the safety and protection of persons who would use that portion of the street during the temporary closing; and

WHEREAS, it is the opinion of this City Council that it is necessary, in order to allow for a bicycle race sponsored by the American Youth Hostels Competition Club to be held on April 19, 1975, to temporarily close those certain Balboa Park streets forming a loop in the southwest corner of Balboa Park and known as Balboa Drive and 8th Avenue Drive, which loop extends for approximately 0.8 miles; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That those portions of Balboa Drive and 8th Avenue Drive which form a loop located in the southwest corner of Balboa Park and consisting of approximately 0.8 miles of right of way be temporarily closed from 5 a.m. until 12 noon on Saturday, April 19, 1975 for a bicycle race.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to post any and all necessary signs and barricades to effectuate said temporary closing.
