Two less men are needed and for a much shorter time.
Ernest Hamilton	WATER UTILITIES DEPARTMENT	\$485	This Intermediate Clerk devised a new system for handling the situation when bills are returned by the Post Office. The notice he suggested is mailed out instead of hand delivered, and has been found 80% effective compared to the former 30%. A total of \$4852 in field trips, vehicle cost and materials is saved per year. The system has proven effective for over a year.
William B. Cunningham	n POLICE DEPARTMENT		Officer Cunningham made a thorough analysis of the procedure for handling shoplifting cases. He proposed a new system that permits store security personnel to field release many of those arrested. They will later will be sent notify warrants. This arrangement frees 497 hours per year of Officer time and also saves clerical time; the total amounting to \$3900 per year. The system has been in effect for 9 months
