

RESOLUTION NO. 212980

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Gold Coast Drive, affecting a portion of Lot 1127, Mira Mesa Verde Unit No. 11, according to Map thereof No. 6701, filed in the office of the County Recorder of San Diego County; and

WHEREAS, the Engineering and Development Department has requested that the City revest these abutter's rights of access in the property to MARTIAL J. MATTEAU and THERESE A. MATTEAU to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, a fee of sixty dollars (\$60) has been received to cover the processing of this request; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf

of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 750789, to MARTIAL J. MATTEAU and THERESE A. MATTEAU, husband and wife as joint tenants, of Lot 1127, Mira Mesa Verde Unit No. 11, effecting the revestment of those abutter's rights of access to Gold Coast Drive of said Lot 1127, Mira Mesa Verde Unit No. 11, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
