
RESOLUTION NO. 212994

BE IT RESOLVED by the City Council of The City of San Diego that the Council hereby declares its opposition to Senate Bill 175 introduced by Senator Marks which would amend the Brown Act and, among other matters, require mailed notice of all Council meetings, eliminate the present Council practice of handling certain matters under unanimous consent, eliminate the use of special meetings for other than unforeseen emergency conditions and extend the Brown Act to appointments to the City Council and to boards, commissions and committees of the City.

BE IT FURTHER RESOLVED, that the Legislative Representative is hereby directed to make the Council's opposition known in its contacts with the Legislature of the State of California.
