WHEREAS, the Combined Arts and Education Council of San Diego County (COMBO) is a unique and successful fund-raising organization which supports cultural and performing arts in San Diego County, primarily in the metropolitan area; and

WHEREAS, the need for additional funds has grown as COMBO adds new organizations and as presently funded groups expand their programs; and

WHEREAS, COMBO believes that no significant additional funds can be raised under its present format for fund-raising activities; and

WHEREAS, to resolve this complex situation, COMBO is organizing a 100-member Fact Finding Committee representative of all major population elements of the County; and

WHEREAS, the National Endowment for the Arts sponsors a "City Spirit Grants Program" which awards monetary grants for projects that will bring the arts more effectively into the life of the community, both now and for the future; and

WHEREAS, COMBO requires such grant to help develop, via the 100-member Fact Finding Committee, intensive information on areas of the arts which may be better served by COMBO; and

WHEREAS, said grant funds would provide staff support for the Fact Finding Committee's study and synthesized report; and

WHEREAS, in applying for said grant, it is most desirable that the local governments affected indicate their endorsement and support for such endeavor; and

WHEREAS, the City Council wishes to express its support for such undertaking; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the citizens of the City, does hereby support and endorse the application of the Combined Arts and Education Council of San Diego County for a project grant from the National Endowment for the Arts.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to forward a copy of this resolution to COMBO for said grant application purposes.
