That the attached petition for the improvement of the unimproved portion of ALLEY, BLOCK 5, VENICE PARK, by grading and paving as an alley section under the provisions of the California Improvement Act of 1911 is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the unimproved portion of ALLEY, BLOCK 5, VENICE PARK, in The City of San Diego, by grading and paving as an alley section, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned, all said work to be done under the Improvement Act of 1911.
