STEFFANI of the firm of FRANK PISANO & ASSOCIATES for professional services required for the design of a bicycle track in the Morley Field Area of Balboa Park, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 750890.

BE IT FURTHER RESOLVED, that the expenditure of \$5,000 is hereby authorized out of Park and Recreation Bond Fund 725 of The City of San Diego, solely and exclusively, for the design, construction and related expenses related to the aforesaid agreement.

BE IT FURTHER RESOLVED, that this Council does hereby commend E. C. Steffani for the generous donation of his personal time on this project for a fee of one dollar and this Council does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to him.
