BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY regarding the widening of Miramar Road at P.U.C. Crossing No. 2-253.80-C, and the maintenance of railroad crossing protection signals at said crossing, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 750895.

BE IT FURTHER RESOLVED, that the expenditure of \$20,000.00 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the street widening and crossing signal installation at the P.U.C. crossing described hereinabove.

BE IT FURTHER RESOLVED, that Resolution No. 211751, adopted October 10, 1974 be and it is hereby rescinded.
