WHEREAS, a 45-inch sewer main in the area of Pacific Highway and Sassafras Street has broken and is in need of immediate emergency repair; and

WHEREAS, the breaks in the pipe are causing amounts of raw sewage to flow through the storm drain system into San Diego Bay; and


WHEREAS, the flow of raw sewage into San Diego Bay creates a potential health hazard if allowed to continued; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That because an emergency repair situation exists, and because the public interest and welfare demand the immediate expenditure of public money for the purchase of replacement pipe needed by City forces to repair said sewer main without the delay of advertising for bids, and pursuant to the emergency expenditure provisions contained in the Charter of The City of San Diego, Section 94, the necessary contract for purchasing 250 feet of 27-inch vitrified clay pipe at a cost of \$20.75 per foot for a total cost of \$5,187.50, terms net plus sales tax, shall be awarded to Pacific Clay Products, Inc., and the City Manager is hereby authorized to execute said contract subject to the City Attorney's approving the contract as to form and legality prior to its execution by the City Manager.
