


RESOLUTION No. 213071Adopted on APR 17 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, a Lease Agreement with ALBERT W. HUBBARD and MILDRED E. HUBBARD, husband and wife, whereby City leases Lot 9, Block 18, Del Mar Heights, Map No. 157, value of said property appraised at \$25,000 by Property Department Staff, for a one year term commencing April 20, 1975 at a rental of \$140 per month plus utilities and taxes, said premises to be used as a temporary municipal fire station facility, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 750922.

That the expenditure of \$647.70 from General Fund 100, Fire Department Budget 1631 is hereby authorized solely and exclusively to provide funds for the above stated purpose.
