

RESOLUTION No. 213076Adopted on APR 17 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to pay the sum of \$3,402 in settlement of each and every claim against The City of San Diego, its agents and employees, resulting from alleged property damage and the inverse condemnation of real property resulting from the land shift which occurred on or about March 6, 1971, allegedly resulting from the construction of a sewer line by The City of San Diego over and across certain portions of plaintiff's real property.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to issue a warrant check in the amount of \$3,402, to Shell Oil Company, Inc., successor in interest to Sonico, Inc., in full settlement of all claims.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to accept on behalf of The City of San Diego an easement of real property pursuant to the easement agreement on file in the office of the City Clerk as Document No. 751075; and said City Manager is further authorized to execute said agreement on behalf of The City of San Diego.




