WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Byron L. Doane	WATER UTILITIES DEPARTMENT	\$1,000	Mr. Doane, a Senior Utility Supervisor, designed an ingenious jet siphon device to be used for clearing sand, gravel and rock from City water filtration beds. This operation formerly required many hours of back-breaking hand labor and a rented conveyor requiring installation and removal. The new system simply uses water through the siphon pump to draw tons of material out of each filter bed. The same syphon pump is then used to replace the sand, gravel and rocks with fresh material. \$12,303 is saved for each filter at Miramar and Alvarado. \$463 is saved for each filter at Otay As the process is required periodically, The average saving each year is \$21,232.
