This was tried and found to be a time-saving improvement. It will save a net amount of \$253 the first year, and five or six times that ultimately.
Doris Uzdavines	GENERAL SERVICES DEPARTMENT Buildings Division	\$20	This Intermediate Typist was concerned about the time required to find the cost accounting for about 460 non-centrex phone bills each month. She found that if we supplied information to the phone company, the bills would show this information on them on all future bills. This has been done for an estimated saving of \$175 per year.
