

RESOLUTION No. 213089


Adopted on APR 24 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JERRY and ELEANOR BALDWIN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of March 7, 1975, conveying to said City a permanent easement and right of way for a public street and incidents thereto across a portion of Lot 53 of Horton's Purchase according to Map thereof No. 283 filed in the office of the San Diego County Recorder on March 9, 1878, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.


