BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, LARWIN - SAN DIEGO, INC., that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 745774, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of ENCORE MIRA MESA UNIT NO. 1.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
