

RESOLUTION No. 213133

Adopted on MAY 1 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SOUTHERN CALIFORNIA FIRST NATIONAL BANK, a national banking association, executed in favor of The City of San Diego, bearing date of December 13, 1974, conveying to said City an easement and right of way for a public street and incidents thereto over a portion of Lot 52 lying within Lot 71 of Rancho Mission of San Diego, all in the Highlands, according to Map thereof No. 284, filed in the San Diego County Recorder's Office March 16, 1887, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named ENGINEER ROAD.

That the City Clerk of said City is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution, for record in the office of the County Recorder of San Diego County.
